

CDS 2026 COMPLETE NOTIFICATION: EXAM DATES, ELIGIBILITY & APPLICATION PROCESS

The **Combined Defence Services (CDS) Examination 2026**, conducted by the **Union Public Service Commission (UPSC)**, is a prestigious national-level defence exam for graduates who aspire to become officers in the **Indian Armed Forces**. Through CDS, candidates are selected for the **Indian Military Academy (IMA)**, **Indian Naval Academy (INA)**, **Air Force Academy (AFA)**, and **Officers' Training Academy (OTA)**.

UPSC conducts the CDS exam **twice every year** — CDS-I and CDS-II — offering a golden opportunity to serve the nation with honour and pride.

☐☐ CDS 2026 Eligibility Criteria

1. Nationality

A candidate must be:

- A citizen of India, or
- A subject of Nepal or Bhutan, or
- A Tibetan refugee who came to India before 1 January 1962 with the intention of permanent settlement.

2. Age Limit (As per Academy)

Academy	Age Limit
IMA	19-24 years
INA	19-24 years
AFA	20-24 years
OTA (Men & Women)	19-25 years

☐☐ **Note:** Candidates must be unmarried at the time of application (specific rules apply for each academy).

3. Educational Qualification

Academy	Required Qualification
IMA	Graduation from a recognized university
INA	Engineering degree
AFA	Graduation with Physics & Maths at 10+2

Graduation from a recognized university

Final-year students may apply, subject to fulfilling eligibility at the time of joining.

4. Physical & Medical Standards

Candidates must meet prescribed **medical and physical standards**, including:

- Height & weight standards
- Vision requirements
- Hearing and dental health
- Overall physical fitness

Medical standards are strictly assessed during the medical examination stage.

☐☐ CDS 2026 Application Process (Step-by-Step)

The CDS 2026 application process is **completely online**.

Steps to Apply

1. Visit the UPSC online application portal
2. Click on “CDS-I / CDS-II Examination 2026”
3. Register using a valid email ID and mobile number
4. Fill in personal, academic, and contact details
5. Select preferred academies
6. Upload scanned photograph and signature
7. Pay the application fee
8. Submit the form and download the confirmation page

☐☐ CDS 2026 Selection Process

The selection process consists of **four stages**:

1. **Written Examination (UPSC)**
2. **SSB Interview (5-Day Process)**
3. **Medical Examination**
4. **Final Merit List**

Only candidates clearing each stage move to the next phase.

❏ Frequently Asked Questions (FAQs)

Q1. When will CDS 2026 exam be conducted?

CDS-I 2026 will be held on **12 April 2026** and CDS-II 2026 on **13 September 2026**.

Q2. Can female candidates apply for CDS 2026?

Yes, female candidates can apply for **OTA (Non-Technical)** entry.

Q3. Is there negative marking in CDS exam?

Yes, negative marking is applicable for wrong answers.

Q4. Can final-year students apply for CDS?

Yes, final-year students can apply provided they meet eligibility before joining.

Q5. How many attempts are allowed for CDS?

There is **no attempt limit**. Candidates can apply until they meet age criteria.

Q6. Is Maths compulsory for OTA candidates?

No, OTA candidates do **not** have a Mathematics paper.

Q7. What happens after clearing the written exam?

Candidates are called for **SSB Interview**, followed by medical examination and final merit list.
