Step 1: Qualify NEET (Mandatory)

- Appear for NEET-UG
- Secure a **valid qualifying score**

- Keep your **NEET Roll Number & Scorecard** ready

1. Visit the **Indian Army Recruitment website**
2. Click on **MNS SSC Entry Notification**

3. Register & apply online
4. Upload qualification certificates (BSc/MSc Nursing, Registration)
5. Pay fee (if applicable)
6. Download admit card for interview/written test
7. Attend interview & medical examination

Shortlisting Based on NEET	August
Interview & Medical	September – October
Final Merit List	November
Course Commencement	January

- NEET Scorecard
- Aadhaar / Passport
