NDA Eligibility Criteria: Key Considerations

1. Age Limit & Relaxation

- There is **no age relaxation** for any category.
- Candidates must strictly fall within the given birthdate range for the respective NDA exam.

2. Educational Qualification

- **For Army Wing:** Candidates must have passed **Class 12 (10+2) or equivalent** from a recognized board.

- **For Air Force & Naval Wings:** Candidates must have passed **Class 12 with Physics and Mathematics**.
- **Can 11th Students Apply?:** No, **11th-grade students are not eligible**. Only those who have completed or are appearing for **Class 12** exams are eligible to apply.

3. Marital Status & Gender

- Only **unmarried male and female candidates** can apply for the NDA exam.

4. Nationality

Candidates must be:

- **Indian citizens**, or
- **Subjects of Bhutan/Nepal**, or
- Tibetan refugees who came to India before January 1, 1962, with the intention of permanent settlement.
