

NEET 2026 Complete Notification: Exam Date, Eligibility & Application Process

Introduction: What is NEET 2026?

NEET (National Eligibility cum Entrance Test) is India's **single national-level medical entrance examination** conducted for admission into **MBBS, BDS, BAMS, BHMS, BUMS and other undergraduate medical courses**. The exam is conducted by the **National Testing Agency (NTA)** and is mandatory for admission to government, private, deemed, and central universities across India.

NEET 2026 Eligibility Criteria

Candidates must fulfill **all eligibility conditions** to apply for NEET 2026.

1. Nationality

- Indian Citizens
- Non-Resident Indians (NRIs)
- Overseas Citizens of India (OCI)
- Foreign Nationals

2. Age Limit

- **Minimum Age:** 17 years as on or before **31 December 2026**
- **Upper Age Limit:** No upper age limit (as per current rules)

3. Educational Qualification

Candidates must have:

- Passed **Class 12 or equivalent examination**
- Studied **Physics, Chemistry, Biology/Biotechnology, and English** as compulsory subjects
- Passed from a recognized board

4. Minimum Qualifying Marks (PCB)

Category	Minimum Marks Required
General / EWS	50%
OBC / SC / ST	40%
PwD (General)	45%

Documents Required for Eligibility

- Class 10 certificate (Date of Birth proof)
- Class 12 mark sheet
- Aadhaar Card / Passport / ID proof
- Category certificate (if applicable)
- Disability certificate (if applicable)

NEET 2026 Application Process - Step-by-Step Guide

Step 1: Registration

- Visit the official NEET portal
- Click on *New Registration*
- Enter basic details such as name, date of birth, email ID, and mobile number
- Generate application number and password

Step 2: Fill Application Form

- Personal details
- Academic details (Class 10 & 12)
- Communication address
- Exam city preferences

Step 3: Upload Documents

- Passport-size photograph
- Signature
- Left-hand thumb impression
- Class 12 certificate (if available)

Step 4: Pay Application Fee

(Fee is tentative and may change)

Category	Application Fee
General	₹1,700
OBC / EWS	₹1,600
SC / ST	₹1,000

Payment can be made via **debit card, credit card, UPI, or net banking**.

Step 5: Final Submission

- Review all details carefully
- Submit the application
- Download and print the **confirmation page**

Step 6: Correction Window

NTA provides a limited **correction window** to edit certain details after submission.
